- New Police matters : Cllr Brown raised the problem of speeding vehicles in the village particularly along Messingham Lane. The meeting agreed that Roy Hindmarsh should be asked to provide speed evaluation on Messingham Lane with the golden rivers positioned 30 metres inside the 40mph sign from Greetwell travelling towards Scawby.

Golden rivers are also requested on Church Street –when travelling from Brigg – just inside the 30mph area – on the village green side of the Mill Lane junction. Cllr Poole suggested that confirmation should be sought from Roy Hindmarsh that the two identified locations are suitable for a community speed watch sign – if the data acknowledges that there is a speed problem.

Cllr England advised that it was a good time to ask N.L.C to investigate the speeding problems in this area as all authorities currently have to review all their speed restriction areas to ensure that they are appropriate.

It was noted that the new yellow no parking lines recently placed outside Coach House Gardens have helped tremendously – however this has caused congestion at Gainsborogh Lane.
