- ii) New highways matters: Cllr Mrs Powell enquired about the progress being made with the weight limit through the village councillors advised that a long consultation process will take place before such a weight restriction can be imposed.

It was noted that Messingham Road is suffering with lorries travelling to and

the quarry. Cllr Poole suggested that residents take note as to the worst affected

times

during the day so that the haulage company can be approached to try and improve matters for residents.

box is no longer a working kiosk – Cllr frost will have the poster laminated

placed in the kiosk. Cllr Mrs Keyworth suggested that the kiosk be made

secure

- Cllr Frost to look into this.
- ii) Quotation to repair the soffit boards on the pavilion awaiting response from Jim handy man.
- iii) Tree on mound on Vicarage Lane it was agreed that this dead tree should be removed and increase the size of the flower bed next year.
- iv) Quotation to make a flower bed around the tree on the village green in memory of Peter Rhodes £82.84. **IT WAS RESOLVED** unanimously to ask N.L.C to produce this flower bed.
- v) Village seats It was agreed that Cllr Frost would inspect all the seats and advise the meeting next month which seats require attention.
- vi) New village matters Cllr Overal asked the meeting if there was legislation in place regarding the allowable height of conifers. The Chairman advised that if the conifers were causing a problem restricting light then N.L.C could request that they be reduced in height. Conifer trees on Silver Sides lane (on the old caravan site) are very tall –some have been reduced in height during power cable inspections but one or two trees were not reduced in height. Clerk to ask N.L.C to look into the matter.

Cllr Neil Poole advised the meeting that he had just been notified that N.L.C have decided to withdraw from the appeal regarding the Biomass planning appeal and that N.L.C were now likely to ask to agree terms with the applicant.

The enquiry will still go ahead – a N.L.C officer and a member of the N.L.C legal team will attend the enquiry but will not speak at the appeal.

A meeting of the Scawby Brook Residents Association will take place next week- Monday 6th June in the King Billy Public House. The clerk was asked to try and obtain a copy of the new proposed layout for Park Corner.

It was noted that a wind farm planning application has been put in at Redbourne.

Cllr Platts advised the meeting that there is a dead tree in the cemetery – clerk to ask N.L.C if they will remove the tree and if another tree can be planted in its place. Cllr Platts suggested that the excess spoil which occurs when graves are dug – is not removed and this could be responsible for killing the tree. Clerk to ask N.L.C to remove the excess spoil and will advise Cllr Platts of the responses from N.L.C on the above matters. Daffodils for the village – a discussion took place regarding the purchase and planting of bulbs for the village – it was agreed that a sack of bulbs wold be purchased from Springfields in Spalding.

Cllr Platts enquired about the purchase of new play equipment for the play area. Cllr Frost advised that there was no allocation of funds for this in the budget. Clerk to retrieve the minutes relating to the budget setting meeting.
