#### 9. NORTH LINCOLNSHIRE COUNCIL HIGHWAYS MATTERS

i) New highways matters to report:

A request was made for improvement to lighting – reflective signage or similar – when turning into Church Street – from Scawby Road to Scawby.

The public telephone sign situated on West Street facing Church Street should be removed.

Shrubs are overgrown and covering the signs on Old Manor Drive corner.

Shrubs are overgrown and are overhanging the pavement on Chapel Lane – between the chip shop and the Alms Houses.

The road on Church Street is uneven and the depressions hold water which are problematic and will freeze and become icy in winter.

Cllr England advised that £1000 has been allocated to the village of Scawby for snow clearing – over and above the service that N.L.C would normally provide. Cllr Poole suggested that the clerk finds out who is on the list of approved contractors for Scawby.
