Vote: Proposal 2-5 votes recorded in favour, 4 votes recorded against and 3 abstentions.

The substantive proposal won a majority of votes and was therefore voted upon again gaining 6 votes in favour and 5 votes against and 1 abstention.

**IT WAS RESOLVED** to set a precept of £29,000 for the financial year 2012/13.
