THE MINUTES OF THE MEETING OF SCAWBY PARISH COUNCIL HELD ON WEDNESDAY 5th SEPTEMBER 2012 at 7.00pm IN THE VILLAGE HALL.

 In the Chair : Cllr T Barker until 7.30pm, Cllr R T Matthews then took over the chair.
 Also present: Cllr Mrs Jarratt, M Burkinshaw, Cllr Mrs Powell, P Johnson, D Hulse, J Kitwood, B Overal, Cllr Mrs Keyworth.
 In attendance : Mrs K Pickering – Clerk. Four members of the public.

PUBLIC FORUM

Cllr Barker took the chair for this section of the meeting.

Mr & Mrs Britt who reside on Gainsborough Lane, attended the meeting to advise the parish councillors of their concerns regarding the proposed Centrica Biomass power plant. Mr Britt expressed concerns regarding the visual impact the plant will have on the area as the building is going to be too extremely large. There are concerns of traffic problems, in conjunction with the ECO2 plant the volume of HGV lorries travelling through the area will be unacceptable. There will also be noise pollution from the generator, trains, lorries and the conveyor belt along with light pollution from the plant. Mr Britt did not feel that the plant would provide local employment in either the short or long term and there would be no net gain of employment. Cllr Overal, who had attended a meeting with Nic Dakin MP regarding this proposed plant responded to some of Mr Britts concerns. Mr Britt was advised that when the planning application comes before the council his concerns would certainly be taken into account.

Mrs Britt asked if anything could be done about the speeding vehicles along Gainsborough Lane – the clerk suggested that she ask Roy Hindmarsh to put in place 'Golden Rivers' which would record the speed data and then hopefully speed enforcement or the extension of the 30mph limit further along Gainsborough Lane might be implemented.

Mr Hancock advised the meeting about inconsiderate parking in Larch Grove – it is a narrow road and cars are parking on the pavement and blocking access to the Grove. It was suggested that the Police are notified at the NATS meeting and the clerk ask N.L.C if there is anything that can be done to improve the situation.

Cllr Matthews took the chair for this section of the meeting.

IT WAS RESOLVED unanimously to adopt the minutes of the meeting held on $1^{\rm st}$ August

4. MATTERS ARISING FROM THE MINUTES OF THE PARISH COUNCIL MEETING HELD ON 1st AUGUST 2012.

- Inconsiderate parking on Chapel Lane leaflets, provided by Roy Hindmarsh, have been placed on cars in the vicinity and are in the Post Office. Cllr Matthews agreed to try and 'personalise' the leaflet to the specific problem in Chapel Lane. Cllr Mrs Keyworth thought that the area did seem quieter of late.
- Land between 37 and 39 Messingham Lane off St Joans Drive the meeting was advised that the parish council has applied to register this piece of land.
 Acknowledgement of the application has been received but no further update available.
- iii) Church Street repairs and weight limit Highways have advised that they are still trying to obtain some funding for the re-surfacing of Church Street. Patching work would not be sufficient to solve the problem in Church Street, a complete resurface is required.

It was noted that highways officers are attending the next NATS meeting and this matter will be raised at the NATS meeting.

Pot holes in Mill Lane require urgent attention.

- Scawby Brook Discussions still taking place regarding the best way to stop residents parking their vehicles on the grass verges. Repairs and patching has taken place on Silversides lane. The overgrown hedge and associated weeds encroaching the pavement on Silversides lane is still outstanding – clerk to contact N.L.C.
- Report on meeting with Nic Dakin regarding the Centric Biomass Power Station this has been covered in the public forum section of the meeting. Cllr Overal asked Cllr Matthews to contact Nic DakinMP regarding the proposal to prevent flooding occurring – as Cllr Overal is not happy with Centric's propsals. Cllr Matthews advised that another meeting is planning and that Nic Dakin would like Cllr Overal to attend this meeting.
- vi) Sturton Lane/Ermine Street gated road The estate have written to N.L.C expressing concerns regarding the 'gating' of this road. N.L.C advise that the barriers have been ordered along with new bridleway signage.
