**IT WAS RESOLVED** unanimously to adopt the minutes of the meeting held on 10th October 2012 and authorise the Chairman to sign the minutes.

# 4. MATTERS ARISING FROM THE MINUTES OF THE PARISH COUNCIL MEETING HELD ON 10<sup>th</sup> OCTOBER 2012.

- i) Land between 37 and 39 Messingham Lane off St Joans Drive No further update available.
- ii) Civic Service date confirmed as 18<sup>th</sup> November 2012. Service arranged and Cllr's R T Matthews and J Frost have agreed to read the lessons. Wine and refreshments to be purchased.
- iii) School sign N.L.C have agreed that this sign should have had planning permission an application is likely to be submitted for retrospective permission.
- iv) Garage business run from a private residence This matter has been investigated by N.L.C and the owner of the business is meeting with a representative of N.L.C to discuss the matter.

### 9. POLICE MATTERS.

- i) Ridge ward crime report circulated by email when available and hard copies to those

- iii) New Police matters to report: Leaflets have been placed on cars parking inconsiderately near the Post Office and this matter has improved.

## 10. NORTH LINCOLNSHIRE COUNCIL HIGHWAYS MATTERS

i) New highways matters: Cllr Johnson advised the meeting that the repairs to Church Street were inadequate and insufficient. Water will still stand in certain areas on the road and will freeze in adverse conditions. Clerk to ask N.L.C to re-inspect the road. Cllr Barker advised the meeting of a document – Scawby Conservation Appraisal – written in March 2005 which stated that busy traffic NEEDS to be controlled. Cllr Barker felt that this document ought to be brought to the attention of N.L.C in light of the heavy volume of traffic travelling along Messingham Lane and Church Street to access Brigg.

- i) Remembrance Day Service Sunday 11<sup>th</sup> November leave the village hall at 10.30pm.
- ii) Overgrown hedge on Chapel Lane Letter written to owners to ask to trim back the hedge.
- iii) Nettles Vicarage lane close to entrance to the hall N.L.C have agreed to tidy.
- iv) Hedge Sturton Lane this hedge has been cut back by the farmer.
- v) New village matters:
  - a) Cllr Hulse, on behalf of Cllr Overal asked if there was any progress in improving the grass verges at Scawby Brook. The clerk advised that if the grass verges are reinstated they will only be parked on and churned up again and N.L.C do not have the budget to tarmac the verges. It is unlikely, in the near future, to have any improvements to these verges.
  - b) Hedge on West Street encroaching the pavement Cllr Mrs Powell to email the clerk with the address.
  - c) Christmas Tree The subject of a Christmas Tree to be positioned on the village green was raised. It was thought that power could be obtained from the telephone box. Cllr Mrs Jarratt to ask Jim Brown if the estate will donate a tree and clerk to ask Richard Coleman if it is possible to connect lights to the tree at the green.
  - d) Safety Fencing opposite the village green appears obsolete and not used for any purpose clerk to ask if it can be removed as it is an eyesore I the most attractive part of the village.
  - e) Cllr Barker asked that the planting of trees be placed on the agenda as some of the mature trees in the village particularly Beech trees are coming to the end of their natural life.
  - f) Cllr Platts advised that he had been contacted by Brigg Town Cricket Club about the possibility of the club working on and eventually playing cricket on the pitch at the playing fields. It was agreed that Cllr Platts should progress this matter with the cricket club and report back to the next meeting. This should be a subject on the next meeting agenda for an update.
  - g) Website The website needs keeping up to date clerk to endeavour to do this!
  - h) Scawby Events Team village map the position for the village map has been decided and removing the bin (to replace with the map) will cost £35.73 +vat. The bin is not likely to be useable after removal. Clerk to get permission from N.L.C to place the map in this location.
